

## **FAST ORANGE & O'REILLY GIFT CARD SWEEPSTAKES** (The "Sweepstakes")

### OFFICIAL RULES

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE, PAYMENT, OR OPT-IN TO MAILING LIST WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ENTRIES RECEIVED. VOID WHERE PROHIBITED BY LAW.**

**2. ADMINISTRATOR:** The Sweepstakes is administered by ITW Permatex ("Administrator"), 6875 Parkland Blvd, Solon, Ohio 44139.

**3. ELIGIBILITY:** The Sweepstakes is open to legal residents of the United States of America, including the District of Columbia, Puerto Rico, and US Virgin Islands. Persons residing in any other jurisdictions are not eligible to enter the Sweepstakes. You must be at least eighteen (18) years of age at time of entry, or the legal age of majority in your jurisdiction, whichever is greater. **5. HOW TO ENTER:** Enter the Sweepstakes by visiting the Fast Orange website at: <https://fastorangeclean.com/win-500-oreilly-gift-card/>, during the Sweepstakes Period to complete and submit an online entry form providing your name, e-mail address, phone number, and a picture of any Fast Orange product ("Entry"). The picture of the Fast Orange product need not be a purchased product; rather, the picture may be of a Fast Orange product found online, in a store, or an actual purchased product.

**Limit one (1) Entry per person/email address/phone number.**

**6. ENTRY TERMS:** Any Entries received in excess of the preceding entry limit for a participant will be disqualified. Any attempt by a participant to obtain more than the stated number of Entries as per the applicable limit by using multiple or different email addresses or identities (or any other artifice or device) will void all of that participant's Entries and that participant will be disqualified from the Sweepstakes. If more than the stated number of Entries as per the applicable limit are received from any one (1) person or email address, only the first Entry will be considered a valid Entry and all

other Entries will be disqualified. In the event of a dispute over the identity of a participant, the Entry will be deemed submitted by the Authorized Account Holder of the email address submitted at time of Entry.
